Food Distribution - The Food Bank, which operates like a grocery store, distributes healthy and culturally appropriate food to individuals and families requiring food assistance throughout Seattle. For its Home Delivery and Weekend Food For Kids Programs the organization serves eight Seattle zip codes in the neighborhoods of Ballard, Magnolia, Queen Anne, South Lake Union, Fremont, Phinney Ridge, Greenwood, Greenlake, and Licton Springs. The Food Bank and home delivery programs distributed more than 2.8 million pounds of food over the course of the year. The Organization had 79,487 visits and deliveries, nearly 18% more than the 2020-21 fiscal year. The Weekend Food for Kids Program provided approximately 22,033 bags of food to approximately 600 students in the Seattle Area. The Food Bank also distributed approximately 13,000 of the 22,033 bags through the Home Delivery, Drive Thru and No-Cook programs.

Client Services - The Organization's Community Resource Hub had a total of 837 touchpoints with clients, which included 467 rental assistance to prevent homelessness, 10 move-in deposits, 28 utilities, 229 IDs, and 103 Licenses. In addition, the Organization was able to partner with other agencies for 310 connections to other critical services.
